Definitions

Duncan Dynamics Gymnastics Club (Referred to going forward as "DDGC") is the organization offering gymnastics services and includes its offices, premises, landlords, representatives, volunteer board of directors, coaches and staff, as well as contractors and volunteers.

Members are the primary account holders of a DDGC Account.

Participants are the person(s) who attend a DDGC offering or event. Participant Profiles are managed and maintained under one Member Account (the Primary).

Equipment includes all items used and housed within DDGC premises, including the premises itself, as well as items temporarily under DDGC's responsibility or temporarily outside of the premises.

Offering(s) or Event(s) are the services offered by DDGC through the duty of work by its staff, contractors, volunteers, directors and affiliates.

Acknowledgments

I have read the policies and sections attached to the DDGC Rules, Terms & Conditions and agree to uphold and abide by the standards and expectations described within each DDGC policy section. I will be respectful and hold any participants under my name to the same standards so that gymnastics can remain inclusive, safe, and available to all in this community.

I understand that if I, or my participant, conducts ourselves in a manner that puts others at risk or is considered harmful that my participant will be removed from the program and I will not be eligible for any proration or credits for the services paid and that DDGC reserves the right to deny service going forward in the event of continued offenses or high level of severity.

I acknowledge that I am solely responsible for any charges and due balances on my account and will contact DDGC immediately to arrange a payment arrangement if my account falls into arrears. If my account is in arrears for more than 60 days, I understand that DDGC may remove my participant from the program and I will be denied service until I have paid any remaining dues and my account is brought to a current status.

I agree to keep my account current not only regarding payments, but also with updating emergency contact information, permissions, and anything else related to the management of my account.

I understand that I can contact DDGC by phone, office or email and am encouraged to do so for things such as general inquiries, accommodations requests, payment plan updates, absences or illnesses, withdrawal or transfer requests, and any other questions or concerns.
